

## NETWORK/INTERNET USER AGREEMENT (For Students Under Age 18)

### Parent/Guardian/Sponsor

As the parent/guardian/sponsor of the above named student, I have read the Concord Public Schools and Concord-Carlisle Regional School District's Electronic Communication Policy and Administrative Procedures and have discussed with my son/daughter his/her responsibilities regarding the use of the school's network. I understand that access to the Internet is designed for educational purposes and that the school districts will provide reasonable supervision of my son/daughter's use of this resource when it is used within the context of activities that occur within regularly scheduled class time. I recognize that some controversial material exists on the Internet and that, from time to time, some of it may unexpectedly appear while he/she is engaged in legitimate academic pursuits.

I also understand that my son/daughter may be accessing the Internet outside of the context of regularly scheduled class time/school day and that the school districts may not be able to provide comparable supervision of my son/daughter's use of the Internet during these instances. In consideration for access to the district network extended to my child during these *non-class times*, I will not hold the Concord Public Schools and/or Concord-Carlisle Regional School District (or any of their agents, employees, or school committee members) (collectively, the "districts") liable for any materials my son/daughter acquires or transmits via, or any injuries he/she may incur as result of his/her use of the schools' computer network and/or Internet connection. I further agree that I will not hold the districts liable for any losses, costs, or damages incurred as a result of my son/daughter's violation of the Electronic Communication Policy and Administrative Procedures.

As use of the network proliferates, classroom and/or school web pages may be developed. Should one be developed by my son/daughter's teacher(s) or by anyone else associated/employed by the districts, there may be occasion when my child's picture, or work might appear. In such instances,

For elementary school students, this agreement will remain in effect for the duration of the student's enrollment at the K-5 level and will be renewed when he/she enters middle school. For middle school students, this agreement will remain in effect for the duration of their enrollment at the middle school and will be renewed when he/she enters high school. For high school students, this user agreement will remain in effect for the duration of their enrollment at the high school. This agreement may be revoked in writing at any time.

I have read the Concord Public Schools and Concord-Carlisle Regional School District's Electronic Communication Policy and Administrative Procedures and I agree to abide by their provisions. I am also aware of my responsibilities regarding the use of the school's network. I understand that access to the Internet is designed for educational purposes and that the school districts will provide reasonable supervision of my use of this resource when it is accessed within the context of activities that occur within regularly scheduled class time.

I also understand that I may be accessing the Internet outside of the context of regularly scheduled class time/school day and that the school districts may not be able to provide comparable supervision of my use of the Internet during these instances. In consideration for the access to the district network extended to me during these non-class times, I will not hold the Concord Public Schools and/or Concord-Carlisle Regional School District (or any of their agents, employees, or school committee members) (collectively, the "districts") liable for any materials I acquire or transmit via, or any injuries I may incur as a result of my use of, the schools' computer network and/or Internet connection. I further agree that I will not hold the districts liable for any losses, costs, or damages incurred as a result of my violation of the Electronic Communication Policy and Administrative Procedures.

I understand that violation of these provisions or other inappropriate use may result in disciplinary action including but not limited to suspension or revocation of privileges, suspension or expulsion from school, and criminal prosecution.

As use of the network proliferates, classroom and/or school web pages may be developed. Should one be developed by my teacher(s) or by anyone else associated/employed by the districts, there may be occasion when my name, picture, or work might appear. In such instances,
